## 新型專班特色與獎助學金

### Features and Scholarships of the INTENSE Program

#### 一、 推動模式：政府及企業共同補助

##### Implementation Model: Joint Funding by the Government and Enterprises

- (一) 由國家發展基金（下簡稱國發基金）提供產學獎助金，包含學生初次來臺相關必要行政費用、單程機票與最多2年學雜費，並由產業提供每位學生每月新臺幣1萬元以上之生活津貼。

The National Development Fund (hereinafter referred to as the **NDF**) provides industry-academia scholarships and grants, including necessary administrative fees related to students' initial arrival in Taiwan, a one-way airfare, and tuition and miscellaneous fees for up to two years. In addition, participating enterprises shall provide each student with a monthly living allowance of no less than **NTD 10,000**.

- (二) 參與此模式專班之學生，畢業後履行2年就業義務期間，應留臺於國內合作企業任職，不得由合作企業外派至國外分公司任職，或任職於海外臺商企業。

Students enrolled in programs under this implementation model are required, upon graduation, to fulfill a **two-year employment obligation** by working in domestic partner enterprises in Taiwan. During this obligation period, students may not be assigned by partner enterprises to overseas branches, nor may they be employed by Taiwan-invested enterprises located overseas.

#### 二、 學生入學資格：

##### Student Admission Qualifications:

申請學校應訂定新型專班擇優招生標準，以確保所招收之優秀學生符合政府獎助金補助宗旨。

Applying universities shall establish merit-based admission criteria for the INTENSE Program to ensure that admitted outstanding students meet the objectives of government-funded scholarships and grants.

- (一) 招收境外生

##### Admission of Overseas Students

1. 符合外國學生來臺就學辦法、僑生回國就學及輔導辦法及香港澳門居民來臺就學辦法之規定。

Applicants shall meet the requirements set forth in the *Regulations Regarding International Students Undertaking Studies in Taiwan*, the *Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students Returning to Taiwan*, and the *Regulations Regarding Hong Kong and Macau Residents Undertaking Studies in Taiwan*.

2. 以駐外館處所推薦國外學校名單之在學生、畢業生為優先。

Priority shall be given to current students or graduates from overseas institutions recommended by Taiwan's overseas missions.

3. 學生大學在學成績、大學畢業成績或專科畢業成績，平均成績在班級排名或系排名中上程度。

Applicants' academic performance during undergraduate studies, upon graduation from a university, or upon graduation from a junior college shall be at or above the mid-to-upper level in terms of class or departmental ranking.

### 三、 語言能力:

#### Language Proficiency:

申請入學英文授課班級者，英文能力須達 CEFR B1 級(含)以上(第 2 學年第 1 學期結束前華語文能力測驗(TOCFL) 基礎級(Level2，相當於 CEFR A2)聽、讀 2 項皆須達 A2 級(含)以上)。

Applicants to English-taught programs must demonstrate English proficiency at **CEFR B1 level or above**. In addition, **by the end of the first semester of the second academic year**, students must pass both the **listening and reading sections of the Test of Chinese as a Foreign Language (TOCFL) at the Basic Level (Level 2, equivalent to CEFR A2) or above.**

### 四、 新型專班獎學金補助原則：

#### Principles of Scholarship and Grant Support for the INTENSE Program:

符合新型專班申請條件，經申請學校及合作廠商共同甄選及錄取之新型專班學生，經審核通過由政府及企業共同補助之專班，將由國發基金提供產學獎助金給學生，惟已領取我國政府其他獎助學金者，不得重複申請。

Students who meet the eligibility requirements for the INTENSE Program and are jointly selected and admitted by the applying university and cooperating enterprises to programs approved for **joint government–enterprise funding** shall receive industry–academia scholarships and grants provided by the **National Development Fund**. However, students who are already receiving other scholarships or grants funded by the Government of the Republic of China (Taiwan) are **not eligible to apply concurrently**.

### 五、 補助項目及額度上限

#### Subsidized Items and Maximum Funding Amounts

#### (一) 初次來臺的相關必要行政費用：

採一次性補助，包含來臺前的健康檢查費用、簽證費用及文書驗證費用。以地區分列補助上限為：新南向區域國家及其他國家上限1萬元、歐美區域國家上限2萬5,000元(核實報支)。

(原已在臺就學之國際生不予補助)

#### Necessary administrative fees related to initial arrival in Taiwan:

A one-time subsidy covering pre-arrival health examination fees, visa fees, and document authentication fees. The maximum subsidy amounts by region are as follows:

- **NTD 10,000** for students from New Southbound Policy countries and other regions
  - **NTD 25,000** for students from Europe and the Americas
- (Reimbursement shall be made based on actual expenses.)

(International students already studying in Taiwan prior to admission are not eligible.)

#### (二) 學校應請學生檢據核銷，並以收據開立當日之臺灣銀行美金對新臺幣匯率計算。

Universities shall require students to submit supporting documents for reimbursement. The amount shall be calculated using the **USD to NTD exchange rate of the Bank of Taiwan on the date the receipt is issued.**

#### (三) 來臺單程機票：採一次性補助，機票費用以來臺最直接航程之經濟艙單程機票核實請領，新南向區域國家上限為9,000元、歐美區域國家上限3萬5,000元(核實報支)。學校應請學生檢據核銷，並以收據開立當日之臺灣銀行美金對新臺幣匯率計算。(原已在臺就學之國際生不予補助)

#### One-way airfare to Taiwan:

A one-time subsidy covering the actual cost of a one-way economy-class ticket for the most direct route to Taiwan. The maximum subsidy amounts by region are as follows:

- **NTD 9,000** for students from New Southbound Policy countries
- **NTD 35,000** for students from Europe and the Americas

(Reimbursement shall be made based on actual expenses.)

Universities shall require students to submit supporting documents for reimbursement, and the amount shall be calculated using the **USD to NTD exchange rate of the Bank of Taiwan on the date the receipt is issued.**

(International students already studying in Taiwan prior to admission are not eligible.)

(四) 註冊入學後最多2年的學雜費

Tuition and miscellaneous fees for up to two years after enrollment

1. 依學生實際應繳交給學校的學雜費給予補助(核實報支)，每年補助上限為10萬元（一學期上限為5萬元）。

Subsidies shall be provided based on the actual tuition and miscellaneous fees payable by the student to the university (reimbursement based on actual expenses). The maximum subsidy is **NTD 100,000 per academic year (NTD 50,000 per semester).**

2. 學生入學第一年給予學雜費補助，第二年第1學期結束前華語文能力測驗(TOCFL) 中文授課班級者聽、讀2項皆須需達B1級(含)以上、英文授課班級者聽、讀2項皆須達A2級(含)以上，且需通過學校與合作企業審查成績與表現後，擇優核給學雜費補助。倘未通過華語能力測驗者，第2學年第2學期即不得領取學雜費補助。

Tuition and miscellaneous fee subsidies shall be granted in the **first academic year**. For the **second academic year**, students must, **by the end of the first semester**, meet the following language proficiency requirements and pass an evaluation of academic performance and conduct conducted by the university and cooperating enterprises, after which subsidies shall be awarded on a merit basis:

- For **English-taught programs**: both the listening and reading sections of the **TOCFL** must reach **A2 level or above**.
- Students who fail to meet the required Chinese language proficiency standards shall **not be eligible** to receive tuition and miscellaneous fee subsidies in the **second semester of the second academic year**.

## 六、領取學生義務

### Obligations of Scholarship Recipients

- (一) 領取國發基金產學獎助金的學生，依據領取年限具有相應留臺就業年限的義務。

Students who receive industry-academia scholarships and grants funded by the **National Development Fund** shall be subject to a corresponding **obligation to remain employed in Taiwan**, based on the duration of funding received.

- (二) 即領取1年產學獎助金者，具有1年(12個月)留臺就業義務，領取2年產學獎助金者，具有2年(24個月)留臺就業義務。

Students who receive the industry-academia scholarship and grant for **one year** shall be required to fulfill a **one-year (12-month)** employment obligation in Taiwan, while those who receive funding for **two years** shall be required to fulfill a **two-year (24-month)** employment obligation in Taiwan.

## 七、產學獎助金繳還原則

### Repayment Principles for Industry-Academia Scholarships and Grants

- (一) 學生如中途退出專班或畢業後未履約就業者，所受領之產學獎助金繳還原則如下：

Circumstances under which students are not required to repay the scholarship/grant:

1. 屬不可歸責於學生之原因，無須繳還產學獎助金：

Situations **not attributable to the student**:

- (1) 原合作企業因營運調整，於學生在學期間停止提供生活津貼，學生經學校媒合仍無法覓得其他企業願意續予補助生活津貼，致學生中途退出專班者。

If the original partner enterprise discontinues providing the living allowance due to operational adjustments during the student's enrollment, and the student cannot be matched

with another enterprise willing to provide the allowance, resulting in withdrawal from the program.

- (2) 原合作企業因營運調整，於學生畢業時無職缺可聘用，又學生經學校進行就業輔導及媒合其他企業仍無法覓得適合企業聘僱者。

If the original partner enterprise has no available positions for the student upon graduation, and the student cannot be placed in another suitable enterprise through university employment guidance and matching.

- (3) 合作企業於學生就業期間有勞動基準法第十四條第一項規定情形，致學生提出終止契約，又學生經學校進行就業輔導及媒合，仍無法覓得適合企業接續聘僱者。

If, during employment, the partner enterprise violates Article 14, Paragraph 1 of the Labor Standards Act, causing the student to terminate the employment contract, and the student cannot be matched with another suitable enterprise through university guidance.

- (4) 學生死亡、因重大疾病或意外事故不能繼續就學或就業，經衛生福利部新制醫院評鑑合格之教學醫院以上層級，開立認定無法繼續就學或就業證明者，或因事故致家庭巨變無法繼續就學或就業，經學校查證屬實者。

In cases of student death, serious illness, or accidents preventing continuation of study or employment, certified by a teaching hospital or above accredited by the Ministry of Health and Welfare, or in cases of major family crises verified by the university.

2. 屬可歸責於學生之原因，應繳還產學獎助金：

**Circumstances under which students are required to repay the scholarship/grant:**

- (1) 就學期間因個人因素中途退出專班：如申請轉學、轉系、休學返國，經學校輔導後仍放棄繼續就讀專班、或經學校依學則退學、開除學籍等情形。

Withdrawal from the program during study due to personal reasons, including applying for transfer, leave of absence, returning to their home country, or being dismissed/expelled according to school regulations.

- (2) 學生學習表現不佳，未通過學校及企業評核標準，並經學校輔導後仍無改善且依學則處以退學、開除學籍等情形，學生應返還已領之產學獎助金。

Poor academic performance or failure to meet university and enterprise evaluation standards, with no improvement after guidance, resulting in dismissal/expulsion; the student must repay the scholarship/grant received.

- (3) 學生畢業後選擇不至合作企業或相關產業領域就業，或就業後違反公司規定被依法終止勞動契約，並經學校輔導後仍無改善者，學生應返還已領之產學獎助金。

After graduation, if the student chooses not to work at the partner enterprise or in the relevant industry, or violates company regulations leading to lawful termination of the employment contract and shows no improvement after university guidance, the student must repay the scholarship/grant received.

- (二) 學生於合作企業就業期間未滿受領產學獎助金年限(領取1年產學獎助金者須留臺就業12個月、領取2年產學獎助金者須留臺就業24個月)：應依其未就業之月數比例繳還產學獎助金；不滿一月者，以一月計。(如就業地點未在國內，應依未於國內就業之月數比例繳還產學獎助金；不滿一月者，以一月計。)若因中途轉換工作，考量尋職所需時間，參加2年計畫者，於履約日起算，應於2年6個月內完成留臺就業2年之義務；若未就業時間累計超過半年，則應依其未就業之月數比例償還產學獎助金。(參加1年計畫者，於履約日起算，應於1年6個月內完成留臺就業1年之義務；若未就業時間累計超過6個月，則應依其未就業之月數比例償還產學獎助金)。

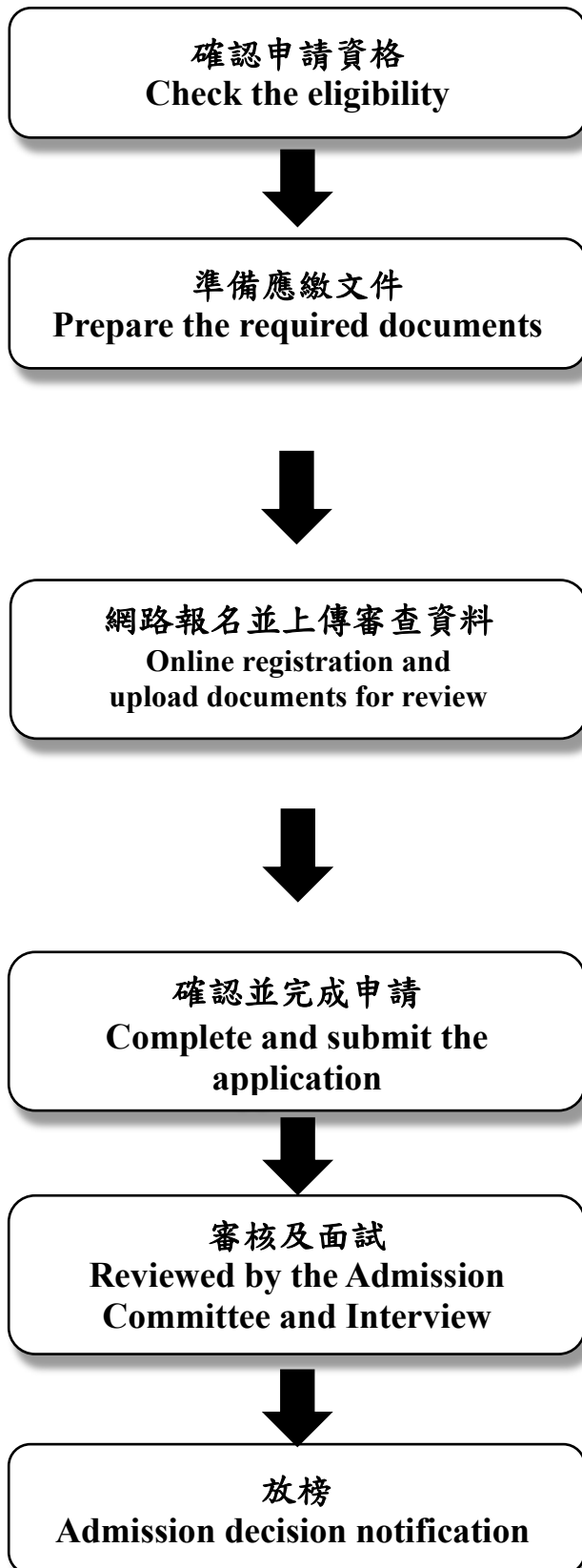
**Proportional repayment based on unfulfilled employment period:**

Students who do not complete the required employment duration at partner enterprises (12 months for one-year scholarship recipients, 24 months for two-year scholarship recipients) must **repay the scholarship proportionally according to the number of months not employed**; any period less

than one month shall be counted as one month.

- If employment occurs outside Taiwan, repayment is based on the number of months not employed in Taiwan, with any period less than one month counted as one month.
- For two-year program participants, considering possible job transition periods, the two-year Taiwan employment obligation must be completed within **2 years and 6 months** from the start date; if the total non-employment period exceeds six months, repayment shall be calculated proportionally.
- For one-year program participants, the one-year Taiwan employment obligation must be completed within **1 year and 6 months** from the start date; if the total non-employment period exceeds six months, repayment shall be calculated proportionally.

## 申請流程 Application Procedures



- 請詳閱簡章並確認申請資格(申請資格請見第 10 頁)  
Please carefully review the brochure and confirm your eligibility (see page 10 for requirements).

- 準備照片、身分證明文件、畢業證書、歷年成績單、自傳、讀書計畫、財力證明、語言能力證明及履歷表。  
Prepare the following documents: a photograph, identification document, diploma, academic transcripts, autobiography, study plan, proof of financial support, language proficiency certificate, and a curriculum vitae (CV).

- 直接上網申請，免報名費，不必將資料寄回。  
Apply online and upload the required documents.  
**NO APPLICATION FEE.** The documents uploaded are not required to be sent to NCUE by post mail.

## 申請注意事項 Application Instructions

### 壹、申請資格 Eligibility

- 一、具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。

A person of foreign nationality who has never held Republic of China (“ROC”) nationality and who does not have overseas Chinese student status at the time of his/her application.

- 二、具外國國籍並符合下列規定，且最近連續居留海外6年以上者：

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years:

- (一)申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

A person who at the time of his/her application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.

- (二)申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿8年。

A person who before the time of his/her application also held dual R.O.C. nationality but no longer does at the time of his/her application shall have renounced his/her R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making his/her application.

- (三)前二款均未曾以僑生身分在臺就學，且未於當學年度經海外聯合招生委員會分發。

The persons referred to in the preceding two subparagraphs must have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year.

- 三、依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.

- 四、具外國國籍並兼具中華民國國籍，且於教育部外國學生來臺就學辦法中華民國100年2月1日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

A person who held both foreign and R.O.C. nationalities and applied for annulment of his/her R.O.C. nationality before the date of effect of the February 1, 2011 amendment to the Regulations Regarding International Students Undertaking Studies in Taiwan may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph B.

※以上所稱中華民國國籍係依中華民國國籍法第二條規定辦理：

The aforementioned ROC nationality is defined in accordance with Article 2 of the Nationality Act:

有下列各款情形之一者，屬中華民國國籍：

A person shall have the national of the ROC under any of the conditions provided by the following Subparagraphs:

- 一、出生時父或母為中華民國國民。

His/her father or mother was a national of the ROC when he/she was born.

二、出生於父或母死亡後，其父或母死亡時為中華民國國民。

He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the ROC at the time of death.

三、出生於中華民國領域內，父母均無可考，或均無國籍。

He/she was born in the territory of the ROC, and his/her parents can't be ascertained or both were stateless persons.

四、歸化者。

He/she has undergone the naturalization process.

前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

Preceding Subparagraph i and Subparagraph ii shall also apply to the persons who were minors at the time of the amendment and promulgation of this Act.

三、具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿6年以上者。

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of his/her application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years.

四、曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外6年以上者。

An applicant who was formerly from the Mainland Area has foreign nationality and has never had household registration in Taiwan, and who at the time of his/her application has resided overseas continuously for at least six years.

第二、三、四項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾120日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾120日予以認定。

The term "overseas" used in Paragraph B, C, D refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days.

但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The only exceptions to this method of calculation are for those who fulfill one of the following requirements with supporting documents. It is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

(一)就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;

(二)就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿2年。

Spent a total period of less than two years undertaking Chinese language classes at a Chinese

language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;

(三)交換學生，其交換期間合計未滿2年。

Spent a total period of less than two years in Taiwan as an exchange student; or

(四)經中央目的事業主管機關許可來臺實習，實習期間合計未滿2年。

Spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.

五、外國學生須符合教育部採認之高中、大學或獨立學院畢業者（請參考教育部網站 <http://www.edu.tw/>）。外國學生具國外高中畢業資格者，得申請入學本校學士班；具學士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校碩士班；具碩士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校博士班。

International students must have graduated from the high schools, colleges or universities recognized by the Ministry of Education (for more information, please visit: <http://www.edu.tw/>). International students with a foreign high school diploma may apply for the undergraduate programs at National Changhua University of Education (hereinafter referred to as "the University"); those with a bachelor's degree or an equivalent academic qualification may apply for the University's Master's programs; those with a Master's degree or an equivalent academic qualification may apply for the University's doctoral programs.

※畢業年級相當於臺灣高級中等學校二年級之國外或香港、澳門地區同級同類學校畢業生得申請本校學士班，惟入學後依本校學則規定，在規定之修業期限內增加其應修之畢業學分數16學分，並得再延長修業年限一年。Graduates from the schools in Hong Kong or Macau where the graduation grade is equivalent to the second grade of Taiwan's high schools may apply for the University's undergraduate programs, but need to take 16 additional credits within the study period in accordance with the University's requirement to complete their study. The said students may apply for an additional year of study.

## 貳、申請方式 Application Method

### 一、網路報名：逾時不予受理。

Online application (Applications received after the deadline will not be processed):

The admission application for international students is initially reviewed by the university's admissions office. Applications that pass the preliminary review are forwarded to the respective department for a secondary review. Those approved are then submitted to the International Student Admissions Committee for approval and subsequently signed by the President. After this process, an admission permit will be issued.

#### 五、「新型專班（國際產業人才教育專班）審查程序」：

##### **INTENSE Program (International Industrial Talents Education Special Program) Review Procedure:**

Applicants for the INTENSE Program must first apply for admission as international degree students at NCUE in accordance with the standard admission procedures. After passing the departmental review, applicants are required to participate in interviews with cooperating enterprises. Those who successfully pass the matching process will be recommended by the university to the Ministry of Education for further review. Only upon approval will applicants be granted eligibility for the INTENSE Program scholarship.

Applicants for undergraduate admission must have earned an average grade and a grade in each of core courses related to the intended field of study at NCUE of at least C or 60. Applicants for graduate admission must have earned an average grade and a grade in each of core courses related to the intended field of study at NCUE of at least B or 70.

Some courses in various departments are divided into two parts, and are offered over both the Fall and Spring semesters. However, due to the prerequisite requirement, students must complete the first part in the Fall semester before they can enroll in the second part in the Spring semester. Therefore, the course planning of students admitted to the Spring semester may be affected, and they may need to adjust their course plans or prepare for a delayed graduation schedule.

According to the requirement of the Ministry of Education, international students who are expelled from a university or college due to behavioral issues, poor academic performance or a conviction under the criminal code may not apply for admission under the “Regulations Regarding International Students Undertaking Studies in Taiwan”. Any violation of this requirement that is verified will result in an immediate cancellation of the individual’s admission.

NCUE students on suspension of study, withdrawal from study, and early graduation shall present the approved school departure procedures form in the current semester of the current academic year and apply for a refund in accordance with the NCUE student departure refund standards.

(二)本校學生離校退費標準如下：於開學日(含當日)前申請休、退學並辦妥離校手續者免繳費，已繳費者全額退費；於開學日(不含當日)之後申請休、退學者，以學期週數(18 週)為基準，每週為一單位，於開學當週申請休、退學並辦妥離校手續者，學雜費(含學分費)退費比例為17/18，每逾一週退費比例遞減1/18，惟逾學期2/3(即第13~18 週)申請休、退學者，所繳學雜費(含學分費)不予退還。

The NCUE student departure refund standards are as follows: Students who apply for suspension of study or withdrawal from study at the start of the semester (inclusive) and complete school departure procedures are not required to pay. Those who have completed payments shall receive a full refund. Students who apply for suspension of study or withdrawal from study and complete school departure procedures after the start of the semester (exclusive) shall receive a refund based on the total number of weeks in the semester (18 weeks). For those who apply for suspension of study or withdrawal from study and complete school departure procedures in the first week of the start of the semester, 17/18 of the tuition and miscellaneous fees (including credit fees) shall be refunded. The refund shall be decreased proportionally by 1/18 every week thereafter. However, students who apply for suspension of study or withdrawal from study after 2/3 of the semester has elapsed (i.e., the 13th to 18th week) shall not receive a refund for the tuition and miscellaneous fees (including credit fees) paid.

The term "overseas" refers to countries or regions other than Mainland China, Hong Kong and Macau. The consecutive years of overseas residency means calendar years in each of which an overseas Chinese student has not spent more than 120 days in Taiwan. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days.
